The long side of the 1½-story 5-bay, center entrance, house faced the road. The wide
frieze had belly windows centered above each of the lower openings. At the time of

the fire the house was abandoned and vegetation in the yard was overgrown.³ The front wall, in the aftermath of the fire, still looked in good shape. However, all was torn down and hauled away shortly afterwards and vegetation quickly reclaimed the footprint.

Masonry details:

Small multi-colored round lakestones appear to have been set 4/Q, darker colored gray limestone quoins. Lintels on the upper street side level were wooden; the others appear to have been split lighter color gray limestones set vertically in flat arches; wooden sills. The double door, unlike the other openings, was set with a limestone lintel and "step up" from the ground to the door (although no steps were present).

Property Details

The last of the Meaker family, Jean *Meaker* Thompson (5th generation of Meaker family) died in 2016. The cobblestone had burned 6 years earlier and the land was vacant. In April 2018 this 39 acre lot was purchased for \$305,000 from her estate and subsequently subdivided into 8 building lots (totaling 26.6 acres). The Historic Centroid is 64118-00-357820. In 2020 a house was constructed on Parcel ID 64118-00-253816 with the address 7214 Fisher Rd.
