Description:

2-story, 5-window, center entrance federal style house; long side facing road. Entrance flanked on each side by two windows, with same sized windows centered above the lower openings. Three risers to the entrance. Chimney at each gable end.

Lintels and sills of wood, limestone quoins. In the north end gable peak was a circular ornament (maybe on opposite end, too—cannot tell from existing photographs). Multi-colored lakestones (many white ones mixed in), 5/Q on the facade, 4/Q on the gable ends. Gable ends had 4 windows (2 down with the others centered above them). Lintel configuration: the center section of the window and door lintels was raised (except those at the roofline on the facade, the straight lintel tops of which butted against the frieze; including the lintel over the basement window in the sandstone block foundation).

The house was located on a rise of ground, now graded by a couple of stepped retaining walls across the frontage.

Page 35, Item 11 (5763 Ridge Chapel Rd) "Glen Beach house, 2-story 5-window; lintels & sills wood; limestone quoins. Lakestones 5/Q."

Verlyn Klahn: "LEON BEACH HOUSE — "... The present owner is Mr. Brusall [sic] who says that the house was built in 1842 and that Leon Beach was the second owner of the house. It is said that the limestone for the foundation was cut by the builder himself."

NOTE: There were several farms owned by the Beach brothers clustered in this area.

Benjamin (Minnie) Beach owned a farm adjacent—Leon was their son. According to his obituary, Leon moved off the farm in 1916 and took up permanent residence in East Rochester in 1921. There is no record of Leon Beach having owned this property.

Carl F Schmidt, *Cobblestone Masonry*, © 1966 — He records this house on page 196, "Eddy-Brusso House". Schmidt's description doesn't correspond to the masonry details in the historic photographs. It appears he is describing another house in the area. There are a number of properties with the name "Eddy" in this area of Williamson.

**NOTE: There is no record of any Eddy family member having owned or lived in this cobblestone house.** Ashley M. Beach married the only child of Benjamin (Florence Josephine) Gibbs and thereby became owner of this "Beach Farm" with the cobblestone house. It passed from him to his son, Glenn, and was sold in 1940 to settle his estate. The only apparent Eddy relationship is two of Ashley's sisters married into the Eddy family. Lavina married Levi Eddy and Lucy married Melville Eddy.

The Glen Beach House

This very large lake stone house is built on a rise of ground on the Cory Corners Road, Marion Twp, Wayne County N.Y. It faces east, has large stone corners and wood sills. Notice the cut of stone over the lower windows and front door. A very imposing structure and the present owners are repairing it for occupancy. They are Mr. & Mrs. Isaac Quaars.

NOTE: Glenn Beach died in 1928. His estate was not settled until 1940. There are no newspaper accounts of whether the wife remained in the house (on the farm); no records of the farm being tenanted out. Perhaps it was abandoned ("present owners are repairing it for occupancy).

Williamson, Jan 8 — Josephine, wife of Ashley Beach, died suddenly Saturday night ... She was born in May, 1848, was the daughter of Mr and Mrs Benjamin Gibbs, and alway resided on the same farm where she was born, two miles southwest of this village ... She leaves, beside her husband, four children, John of Ontario, Mrs Leland Pratt of Newark, Mrs Myron Adams of this village, and Glen Beach who resided with them on the farm; five grandchildren also survive.

News was received here Saturday of the sudden death of Ashley Beach who died on the cars at Council Bluff. He and wife had been making a tour of the west. Mr Beach was well known here. He was 69 years old.

Glenn appears to take over responsibility for farm operations. He and wife were both active in the Williamson Grange, holding various positions. He occasionally advertised for selling oats, timothy, hay, etc in the local paper as well as wanted ads for a single tenant man, by the year.

There were 32 heads of cattle and 6 houses lost and several hundred bushels of grain and feed, besides much

hay, and etc. The buildings were partly insured in the Wayne Co Fire Relief Association and it is estimated that there were over \$8,000.00 loss in all."

Williamson was shocked and last week Wednesday morning to hear of the death of Glen Beach ... Mr Beach was 54 years old and is survived by his wife, Carrie Meeker Beach, three sons, Ivan of Lakeside, Norman of Syracuse University and John at home, one daughter Barbara, a student at Brockport Normal. The funeral was held from the family home on the Beach road.

The estate is not settled until 1940. There is no information relative to how (if) the farm was being run after Glenn dies.

The Ashley Beach farm is put up for auction 4/23/1940.

Quaars Re-Celebrate January 28 Anniversary

"Mr and Mrs Isaac Quaars ...will observe their 50th wedding anniversary ... Mrs and Mrs Quaars have lived most of their married life in the Williamson area. They owned and operated a dairy farm on the Ridge Chapel Road until 1945, at which time they moved into the town of Williamson."

## *BRUSSO*

Nothing was found about "Mr Marvin", the next owner of this property. Regardless, he doesn't appear to have held it for very long, before the Edward Brusso family acquired it.

In the 1960s the newspapers started using actual street addresses. The address here was 451 Ridge Chapel Rd, Williamson. Since that time the street numbers have been changed.

"The second child of Mr & Mrs Edward Brusso, Ridge Chapel Rd, Williamson, born at Highland Hospital on Feb 29. ... Edward John is the new son of the Edward Brusso and weighted at birth 6#, 4oz. The other child is a daughter. Mrs Brusso is the former Carolyn Hoffman, daughter of Mr & Mrs Peter Hoffman, Ridge Rd W, this vicinity."

There are no references to the Brusso family here with regard to the farm or the cobblestone house. There are many newspaper references of the children—births, schools, marriages.

I interviewed this second child of Mr & Mrs Edward Brusso, Edward John, in 2014. He lived there as a child and remembers the family demolishing it in 1964 in favor of a new, modern house.
