A CLERICAL FRAUD

How an Imposter Duped the Carlton Baptist

Church

The congregation of the Carlton Baptist Church are much exercised over the discovery that "Rev" Thomas L. Thomas, alias Jones, who has been pastor of that church for some time, is not a clergyman at all but a fraud of the rankest kind. Mr. Jones' conduct in some business matters, led to an investigation on the part of the church, which revealed the crookedness of his past career. His ordination papers were dated Sunday, May 18, 1882, which was discovered by consulting an almanac to have been Thursday. Further investigation revealed that in 1875 he married Miss Elizabeth Perry, of Shamokin, Pa., and by her had three children. This family he abandoned in 1886 and he married Mrs. Bertha Ludich in Phillpsburg, Pa., with whom he now lives. The committee appointed to investigate the matter have corresponded with all the clergymen from whom Jones presented letters of recommendations, all of whom pronounce them forgeries. Several of them claim to know said Jones and state that he is an

unmitigated fraud. His former wife wrote the committee that she would gladly appear in this state against her husband whenever needed.

Rev. Henry Hill, of Vincentown, New Jersey arrived in Albion, Saturday to appear agains: Jones, who claimed one of his best and stronges recommendations to have been signed by Mr. Hill Rev. A.C. Osborn, D.D., of Albion and Rev. Mr. Hill proccured a warrant for Jones on the charge of forgery and he was arrested. He was taken before a magistrat and held to await the action of the grand jury.

After his arrest Jones sent for Rev. Dr. Osborr and confessed that the charges against him were all true; that his ordination and letters of recommendation were all forged, and that he was no

even a member of any church.

The imposition is the more flagrant, as Jones has performed the ceremony of baptism and marriage."

The unfortunate thing about such a scandal as this, it is seen as bringing discredit on the church ir general. We must always remember to keep sepa rate, the isolated individual as well as the ove publicized nonsense. Now, as one hundred years ago, .01% of any profession are going to fall into a questionable predicament, 'tis best not to be too judgemental.
